



You are cordially invited to be a member of Tobacco Leaf's VIP Lounge membership program. Upon approval of application and receipt of payment, you will gain access to the following valuable benefits:

- Access to 3 distinct VIP member exclusive smoking lounges via swipe card
- Private humidified locker with combination lock (*Optional for a Fee*)
- 10% discount on single cigars, additional 10% discount on boxes (totaling 20% total discount)
- 10% discount on Cigar Accessories
- VIP Membership Gift Card with \$1800 store credit
- Inclusion in Tobacco Leaf Rebate Program (see attached page)
- Access to "Reserved" portion of Outdoor Patio
- Dedicated Service Personnel (when available)
- Complimentary Bottle Storage Behind VIP member bar
- Invitations to promotions and events and priority access to limited release cigars
- No Charge For Glassware/Ice for BYOB Beverages
- Complimentary bottled water, soda, coffee and light refreshments in designated exclusive lounge areas
- 2 Complimentary guest passes per month (additional passes can be purchased for \$25 per pass - complimentary guest passes cannot be rolled over.)
- Dedicated high speed network exclusive to VIP members
- Discounted Rental Rate for Basement Lounge
- Invitations to periodic VIP Member Round table meetings and other member exclusive events

## - REQUISITES

- You must be over the age of 21 to become a member and smoke cigars at Tobacco Leaf Cigar Lounge.
- Tobacco Leaf reserves the right to alter or change the VIP Membership program, at any time based on State or Federal regulations or at the discretion of ownership.
- Payment is due upon signing and is nonrefundable and is nontransferable. Membership is for one year. All memberships will be automatically renewed at the end of the twelve-month period unless notified in writing within 30 days of the end of contract. Membership charges will be automatically applied as per the designated membership payment schedule (yearly, quarterly, or monthly) selected on the contract.
- The payment method specified by member on the Member Contract will be used to charge member dues on a yearly/quarterly/monthly basis. This information will be accessed strictly by TL ownership or a designated staff member only. If payment method is no longer valid or has been changed, it is the responsibility of the member to inform Tobacco Leaf of such an occurrence. If a payment method is repeatedly declined or changed by a member (3 times or more) - membership and access to TL VIP Lounges may be revoked.
- Tobacco Leaf reserves the right to suspend access to any member for non payment after 15 days of membership contract expiring or if payment for the current billing period is not received within 15 days from the start of current billing period. In addition, discounts as well as locker and any other membership privileges will also be suspended until full payment is received. Humidors belonging to members that are 30 days overdue beyond the date of contract expiration, will be emptied and made available for rent. Any contents within the humidor will be discarded at this time.
- Store credit amount of \$150/month will be issued at the beginning of each billing cycle for the month(s) specified in the contract agreement onto member specific gift card. Balances of store credit amount will not be rolled over into next billing cycle. Member must use store credit balance before the new billing cycle begins.
- Member will receive a gift/membership gift card at the beginning of their membership. It will be associated with them specifically and will loaded and carry their store credit balance. Once store credit amount for designated billing cycle is exhausted, member will be responsible for their purchases or any remaining balance.
- Member is to inform TL management of a lost or stolen gift card as soon as possible. TL is not responsible for store credit amount being used by someone other than the designated member.
- Additional guest passes beyond the two allotted per month can be purchased for a charge of \$25 per guest. We request that you inform Tobacco Leaf staff that you are expecting a guest in advance of their visit. You may call, or email the shop. All guests

of members must be accompanied by their sponsoring member at all times. Members are solely responsible for the behavior of their guests.

- Optional Spousal Memberships are available for an additional fee. Spousal Membership can not be transferred or refunded during the billing cycle. There is no additional store credit associated with the spousal membership - other wise the designated spouse will have full membership privileges.
- It is the responsibility of the member to bring their swipe card to access restricted lounge spaces. Staff can allow access to members to these restricted spaces, however if this becomes excessive occurrence - access may be denied. Members will be subject to a fee of \$25 for a replacement swipe card.
- Total VIP Membership will be capped at 150 Members. This is a preliminary number however, and will be very closely monitored and may be adjusted at the discretion of management. We are committed to the comfort of our guests and will try our level best to make sure they accommodated and comfortable. We cannot however guaranty seating for members.

## Humidor Rentals

We value your investment in fine cigars. It is our desire to store your cigars in perfect condition. With that in mind, we ask you note the following:

Each brand of cigars possesses its own specific characteristics. These subtleties in bouquet and flavor may be lost if you do not separate various cigars. We urge you to keep your cigars in boxes, as opposed to placing them loosely in the humidor. Should you need a plastic bag or an empty box for this purpose, please ask a member of our staff.

Occasionally, we may place a hygrometer in your humidor for the purpose of testing the temperature and relative humidity. Please do not remove these devices.

- Humidors are available for rent as an optional “a la carte” service and are subject to availability. Humidor holders are responsible for the contents of their humidor and humidor is intended to store cigars only. Member agrees not to place liquor bottles or glasses, or any other contents not related to premium cigars in their locker.
- There is a \$50 charge to replace the lock of locker or hinges of locker in case of damage due to negligence of locker owner
- Humidor holder agrees to refrain from placing any cigar or other products in his/her humidor that may violate any federal or state laws.
- Humidor holders are responsible for the contents of their humidor and humidor is intended to store cigars only. Member agrees not to place liquor bottles or glasses, or any other contents not related to premium cigars in their locker.
- Only cigars purchased at Tobacco Leaf will be stored in member locker and it is agreed that all tobacco consumed on the premises shall be purchased from Tobacco Leaf.

- Tobacco Leaf reserves the right to open any humidor for the purpose of maintenance. Management reserves the right to conduct periodic inspections of the humidor boxes and their contents without the notification of the box owner. If any item or substance is found that is in violation of the terms of this agreement, management shall notify the box holder that he or she has violated the terms of this agreement, thus terminating this agreement and forfeiting any and all rent payments made under the terms of this agreement.
- Tobacco Leaf reserves the right to revoke the lease of any person/company that does not abide by the policies determined by its management or by this agreement.
- Access to humidors are allowed only during Tobacco Leaf's hours of operations. Tobacco Leaf reserves the right to close for private functions at which time to access to humidors may not be available.

*Please be advised that we continually monitor the temperature and humidity in our personal humidor lockers so that remain at optimum levels. We cannot, however be responsible for the product that is stored in these lockers.*
